The Board composition complies with the Main Market Listing Requirements of Bursa Malaysia that requires a least two (2) Directors or one third (1/3) of the Board, whichever is higher, to be Independent Directors.</p> <p>The Chairman encourages free expression of opinions and healthy debates by all directors, allowing sufficient time for discussion of issues and ensuring that all Directors are able to fully and actively contribute to the deliberations and the Board's decisions fairly reflect Board consensus. Notwithstanding the above, the Board operates in a manner that ensures the Directors exercise independent judgement and the interests of shareholders are always at the forefront when important decisions are made by the Board.</p>

<b>Explanation on application of the practice</b>	:	<p>Considering the recommendation of the Code pertaining to the tenure of an Independent Director exceeding a cumulative term of nine (9) years, the Board holds the view that the ability of an Independent Director to exercise independent judgement is not affected by the length of service. The suitability of an Independent Director to carry out his responsibilities is very much a function of calibre, experience and personal qualities.</p> <p>Mr David Low Teck Wee, Mr Loo Thin Tuck and Tunku Azlan Bin Tunku Aziz have served the Board for more than nine (9) years.</p> <p>The Nomination Committee had assessed the independence of Mr David Low Teck Wee, Mr Loo Thin Tuck and Tunku Azlan Bin Tunku Aziz and recommended to the Board that they be retained as Independent Non-Executive Directors of the Company based on their ability to maintain independent judgement and to express unbiased views without any influence. Mr David Low Teck Wee, Mr Loo Thin Tuck and Tunku Azlan Bin Tunku Aziz are familiar with the Group's business operations, have devoted time and commitment and have exercised due care in discharging their duties and responsibilities as Independent Non-Executive Directors. They have fulfilled the criteria under the definition of Independent Director as defined in the Listing Requirements of Bursa Securities.</p> <p>The Board is recommending and will be seeking annual shareholders' approval in the forthcoming 16th Annual General Meeting to extend the tenureship of Independent Non-Executive Directors, Mr David Low Teck Wee, Mr Loo Thin Tuck and Tunku Azlan Bin Tunku Aziz.</p>

Each Director completed a detailed questionnaire in the Directors' Performance Evaluation which covered matters relevant to the Board performance, amongst others, contribution to interaction, quality of input, understanding of role and personal developments. An evaluation of each Board Committee was done by assessing the structure, roles and responsibilities, performance of the respective Chairman, as well as Committee's performance against its Terms of Reference. The assessment was internally facilitated, whereby results of the assessments had been compiled, documented and reported to the Board accordingly, as part of the Company's ongoing corporate governance practices.</p> <p>Based on the results of the assessment for the financial year ended 31 December 2018, it was concluded that the composition of the Board and its Committees corresponding to its oversight duties and the developments of the Company. The individual performance rating serves as a basis to determine their variable compensation payments and thereby rewards individual performance. The Board Remuneration Policy also covers bonus framework for the Executive Director and key Senior Management, which link their appraisal process to specific reward and incentive outcomes. The appraisal process will assess the individual performance against the Key Performance Indicator targets and competency capability in meeting the Group's core values and Leadership and Management Expectations.</p>
